Question 1: Why are there almost 5,000 respondents who did not answer their current start time or preferred start time?

Response to Question 1: The survey was designed to allow participants to skip questions if they chose. This approach aligns with best practices, which suggest that requiring respondents to answer every question can lead to frustration and potentially lower response rates. Consequently, we do not have specific insights into why participants may have chosen not to answer certain questions.

Question 2: Did the current start times factor out the individuals completing the survey who were associated with different school levels?

Response to Question 2: The data presented focused on respondents from high schools, as this group constituted of the majority of participants. The information is particularly relevant to our discussion today. This emphasis ensures that our findings are pertinent to the issues most prevalent among the largest respondent group.

Question 3: Can you give more insight into what the "other" category includes on slide 13? Did we provide the option for user input in that category?

Response to Question 3: The "Other" category on slides 8 and 9 encapsulates comments from respondents that did not fit into the predefined categories. This allows us to consider a wider range of insights and perspectives that emerge from the survey data.

Question 4: Can you disaggregate the data on slide 13 based on students, teachers, parents, community members, and other district or school staff? It would be insightful to see what each of these subgroups thought.


