# 3. Information, Discussion, and for Possible Action: Interview of Finalists for State Superintendent of Public Instruction (Information and Discussion)

The interviews adhered to the approved structure: Performance Task Presentation, Scoring Period, Eight Formal Questions, and Follow-Up Questions. Dr. Darryl Wyatt presented his performance task, "Statewide Early Literacy Plan to Create Strong Readers for a Strong Nevada," followed by responses to the eight formal interview questions. Next, Dr. Lisa Coons presented her performance task, which focused on accelerating student outcomes through strategies including closing academic gaps and increasing daily attendance, followed by her responses. Dr. Victor Wakefield then presented his performance task on college and career readiness, outlined by the three phrases: "Make it count, make it clear, and make it stick," followed by his responses. Finally, Ms. Amy Suman presented her performance task, "Accelerating Student Outcomes Across Nevada: Attendance = Success," proposing a two-strategy approach to eliminate chronic absenteeism, followed by responses to the eight formal interview questions.

Board Members submitted performance task and interview scorecards following the completion of each candidate's interview segment. No formal action was taken to select finalists at this stage.

#### Appendix A, Item 1: PAT HICKEY

# Appendix A, Item 2: IGNACIO PRADA

My name is Ignasio Prada and I'm the executive director of Futura Academy Charter School, a public charter school in the Nevada State Public Charter School Authority. Our school is in its ninth year currently serving grades K to 5 for 475 students and their families. Every NPF rated year, our small independent school significantly outperformed our neighboring schools, breathing life into our mission to provide a quality option for students in Las Vegas's east side. I'm also the vice chair the charter school association of Nevada representing the more than 70,000 students in public charter schools in Nevada our second largest K to2 public school system however I want to make clear speaker I'm uh speaking only in my personal capacity in support of uh Victor Wakefield as well and not communicating an endorsement of either organization at this point uh but want to provide a few anecdotes that make salient Victor Wakefield's qualities I'm sure you saw from his resume Victor has the experience of a well-qualified uniform candidate a a unicorn candidate. He has national level experience to glean lessons from all sorts of other sectors and places, but he also has a deep context in Nevada and deep experience here in Nevada to understand our history and our context. The two anecdotes I want to provide you with. My first close interactions with Victor came in the form of participating in hot topic events where Victor organized a series of guests across disciplines and industries to talk with educators across a range of ideological backgrounds, experiences, and context. for example, the press, nonprofits, and industry. The conversations were intellectually challenging, fruitful, and even though this happened almost 15 years ago, they stand out as some of the safe and creative spaces to form ideas of experience in Nevada, where he remained a respectful and a fair facilitator. Secondly, when not when launching Coutura Academy, Victor was one of the first community members I met with to gather some feedback in 2016. The conversation with him still stands out for the level of radical cander in challenging and probing questions he asked about our plants. Victor is the kind of person that has the integrity to be the steward of the people and the greater good above all not just in public but in private as I've experienced. It is with great confidence and admiration that I recommend Dr. Darryl Wyatt for the position of Nevada State Superintendent of Public Instruction. I had the privilege of working under his leadership for twelve years while he served as my principal in the Clark County School District. During that time, I witnessed firsthand his visionary leadership, his unwavering commitment to equity, and his ability to transform schools into thriving learning communities.

Dr. Wyatt is not a leader who settles for the status quo. He consistently led our staff to embrace innovative practices that placed us far ahead of many neighboring schools. When he noticed that I was embracing this new tool, he encouraged me to take on a leadership role, training my colleagues on how to integrate technology into their teaching. Dr. Wyatt invested time and resources to ensure staff received proper training and access to nationwide best practices, giving us the confidence and tools to integrate technology effectively into our classrooms. This kind of forward-thinking leadership built a culture where educators were trusted, valued, and equipped to meet the future head-on. His ability to recognize strengths in others and elevate teachers into leadership roles created a ripple effect that advanced the entire school.

Perhaps most telling of his leadership is the loyalty he inspired. When Dr. Wyatt transitioned from leading an elementary school to a middle school, the majority of our staff which included teachers, nurses, office staff, and even custodians chose to follow him. We wanted work where he was. I personally, as well as several others, drove an hour each way, past more than a dozen other schools, just to continue working under his leadership. That kind of commitment from an entire staff is rare, and it speaks volumes about the respect, trust, and admiration he cultivated.

Equally important, Dr. Wyatt was unwavering in his dedication to equity. He led a school community where families often lacked the financial means to provide the resources their children needed. He never accepted that as a limitation. If the school budget could not meet a need, he went beyond the walls of our building to secure community partnerships, ensuring our students had the same opportunities as children in more affluent neighborhoods. This kind of creative, relentless, and gritty advocacy demonstrates exactly the kind of leadership Nevada needs at the state level.

Even beyond our years of working together, Dr. Wyatt has remained my go-to person for professional advice. Whether I had questions about education policy, law, or needed guidance in navigating new challenges, he has

always been there as a trusted mentor. The fact that I still rely on his counsel years later speaks to both his depth of knowledge and his unwavering dedication to supporting educators long after they leave his building. Above all, Dr. Wyatt built a culture of trust and respect. Every staff member knew that he valued our work, supported our growth, and would fight to provide us with the tools we needed. His leadership made it possible for both educators and students to thrive, and his vision continues to influence my practice to this day. Nevada deserves a State Superintendent who understands innovation, equity, and the power of empowering educators. Dr. Wyatt embodies all of these qualities. I am proud to recommend him without reservation, knowing that his leadership will not only elevate Nevada's schools but also transform the lives of countless students and families across the state.
