The Subcommittee will receive a presentation and conduct a discussion regarding the statutory changes to NRS 388G enacted through SB460 (83rd Legislative Session). The review will include an overview of the provisions of NRS 388G affected by SB460, as well as an analysis of related Nevada Administrative Code (NAC) sections that may require amendment or repeal to ensure alignment with the revised statute. The Subcommittee will also consider their next steps in recommending to the full State Board of Education updates to align NAC through the regulatory process.
