#### MEETING MINUTES

#### 1. Call to Order, Roll Call

Meeting was called to order by Chair Hobbs. Quorum was established. Chair Hobbs noted for the record that they are joined by Deputy Attorney General Greg Ott.

Member Jensen moved to approve the flexible agenda. Member Woodhouse seconded. Motion carried.

Member Woodhouse moved to approve the consent agenda. Megan Johnson seconded. Motion carried.

- 5. **Nevada Department of Education Update** (Information and Discussion)
  - The Commission will receive an update on the progress made by the Nevada Department of Education since the last meeting.
    - Megan Peterson, Deputy Superintendent for Student Investment, NDE

Megan Peterson gave an update on the progress made by the NDE since last meeting and went through the list of outstanding deliverables that the Commission still has at task.

• Work Group #3, Current Reporting and Data, Jason Goudie

Member Goudie stated the group has been working on finalization of the report that encapsulates the summary provided in previous meetings and it will be ready for the October meeting.

• Work Group #4, Accountability and New Reporting Framework, Paul Johnson

Member Johnson stated they have a draft report completed, to include strategies to increase efficacy, efficiency, transparency and accountability of public schools, existing metric within SB98 and AB400 and need to upgrade performance framework. They should have it ready for the October meeting.

• Work Group #5, Accountability Outcome and Trends, Dr. Nancy Brune

Member Brune stated they also have a very succinct, readable report and will be ready to present by the October meeting.

7. Information, Discussion, and Possible Action Regarding Updates to Reporting Requirements and Potential Categories for the New Reporting Framework (Information, Discussion, and Possible Action)

The Commission will receive an update on the progress of compiling the necessary data to meet the reporting requirements for Assembly Bill (AB) 400. Subject matter experts will also review tentative

timeframes and dates for future reporting pursuant to AB400. This will include a review of current reporting requirements and recommendations for streamlining.

Pursuant to NRS 387.12463, the Commission shall monitor the implementation of the Pupil-Centered Funding Plan (PCFP) and make recommendations to the Joint Interim Standing Committee on Education that the Commission determines would, within the limits of appropriated funding, improve the implementation of the Pupil-Centered Funding Plan or correct any deficiencies of the Department or any school district or public school in carrying out the Pupil-Centered Funding Plan.

Dr. Krausan gave a presentation and summarized the input they have received from NDE offices about current reporting requirements. Dr. Sean Tanner discussed the timing of future performance reports, when data is received and analyzed by the stated. Members had a discussion and questions were answered. Member Mathur made a motion to advance a recommendation for an Early Release report by November 15th with the spring supplement by March 15th. Member Woodhouse seconded. Motion carried.

Chair Hobbs stated this item was added to the agenda to better understand what the commission is able to do if called upon during the course of the legistlatic session to provide support. Member Mathur made a motion to deputize the Chair to speak on anything in front of the legislature and have the authority to delegate members of the Commission, based on their expertise on a specific topic, to speak in front of the legislature. Member Woodhouse seconded. Motion carried.
