### NAC 388.XXX Petitions to repeal reporting requirements

- 1. The Department shall evaluate all petitions submitted to the Department pursuant to publicly available rubrics, and all determinations will be supported by evaluation scores. The Department shall promulgate a model rubric for use by the superintendent of schools, charter sponsor, or governing body of a university school for profoundly gifted pupils when evaluating individual petitions.
- 2. The Department shall establish a single file specification for use by school and local education agency personnel to submit their petition to their school district and/or board of trustees for review by the superintendent of schools, charter sponsor, or governing body of a university school for profoundly gifted pupils. Submissions to the Department shall adhere to a single file specification.
- 3. Petitions may be submitted by school-level personnel, including but not limited to educators, administrators, and specialized instructional support personnel; personnel supporting a charter management or educational management organization; and local education agency personnel, to include but not limited to district or charter sponsor administrators.
- 4. Petitions should only be submitted to the Department if the reporting requirement is within the jurisdiction of the Department.
- 5. The Department shall promulgate a comprehensive list of reporting requirements under the jurisdiction of the Department to support the evaluation and petition of reporting requirements.
